Appendix to the Branch Operations Manual

1. OPERATIONAL CONTEXT

AmaNtungwa Ka Mbulazi International is a Member-based Collective Organisation. It goes without saying that controversies are inevitable in any group of people, and AmaNtungwa Ka Mbulazi International is no exception.

When managing all controversies arising from the actions and behaviour of Individual Members (**including small groupings**), AmaNtungwa Ka Mbulazi International will always be mindful that the Organisation was established in, and has its headquarters within the Constitutional Dispensation of the Republic of South Africa. **Therefore, all responses to such controversies will ensure that, in line with the Constitution of South Africa, the Freedoms and Rights of Members are not violated.**

Rooted in the timeless Human Values of UBUNTU, our ultimate goal is a perpetually aligned, harmonious, loving, joyful and eternally prosperous Socio-Economic Ecosystem.

The following Cardinal Freedoms constitute the Organisation's Framework for managing all controversies from the actions and behaviour of individual Members of AmaNtungwa Ka Mbulazi International:

2. CARDINAL FREEDOMS FOR INDIVIDUAL MEMBERS OF AMANTUNGWA KA MBULAZI INTERNATIONAL

(While derived from the Freedoms for Individuals enshrined in the Constitution of South Africa, applicable to all Members globally.)

- a) **Freedom of Expression;**
- b) **Freedom of Association;**
- c) **Freedom to Organise and Mobilise for any just cause of one's choice;**
- d) **Freedom to Commemorate and Celebrate the Heritage and Legacy of one's Historical and Current Heroes; and**
- e) **Freedom of Movement.**

AmaNtungwa Ka Mbulazi International shall uphold the above-mentioned Freedoms for Individual Members on provision that:

- i. the Individual Member **does not Incite Violence**;
- ii. the Individual Member **does not Compromise the Freedoms** of others;
- iii. the Individual Member **does not Denigrate the Human Dignity** of others;
- iv. the Individual Member **does not Invade the Privacy** of others; and
- v. the Individual Member **does not Promote Inequality**.

3. CONCLUSION

AmaNtungwa Ka Mbulazi International embraces all the above-mentioned Freedoms, and regards them as sacrosanct. The Organisation shall, wherever appropriate, not only respect, but also defend and support these Freedoms for all Members of our Family.
